## Six Stream Restoration Projects Moving Forward

#### Fish Passage at Stonybrook Creek Road Culverts

The Alameda County Resource Conservation District is working with Alameda County Public Works to provide fish passage for steelhead trout at two county owned road crossing culverts along Palomares Road, on Stonybrook Creek.

The projects will involve retrofitting a county road culvert one mile up Stonybrook Creek and replacing a second culvert a quarter mile further upstream with a free-span bridge. These projects will allow steelhead trout and rainbow trout to access additional spawning and rearing habitat in Stonybrook Creek. The RCD and Alameda County are evaluating potential costs and looking to ensure funding to complete these projects. They will begin contacting potential design firms and coordinating on a conceptual plan this year.

#### Fish Ladders for Lower Alameda Creek

The Alameda County Water District and Alameda County Flood Control District have taken the first step in the permitting process for several fish migration projects in the lower Alameda Creek flood control channel. The projects include installation of a fish ladder along the northern embankment of the Alameda Creek flood control channel over ACWD's Rubber Dam No. 1 (middle rubber dam) and the BART weir; installation of another fish ladder along the northern embankment of the flood control channel and ACWD's Rubber Dam No. 3 (upper rubber dam); and replacement of existing unscreened diversion pipes and installing new cylindrical fish screens at Shinn Pond to prevent juvenile steelhead trout from being trapped.

Design for all the projects is underway, and ACWD recently submitted a Biological Assessment to the Army Corps of Engineers, the first step in the federal permit process for the projects. The environmental review process for the projects will begin this spring. The BART weir/middle dam project is scheduled to be constructed in 2014 and the upper rubber dam fish ladder in 2015. #### **Arroyo Mocho Channel Enhancement and Riparian Restoration**

Zone 7 Water Agency is initiating a pilot project along Arroyo Mocho in Livermore to demonstrate the feasibility of transforming a traditional urban flood control channel into a vegetated stream reach. The project will enhance habitat for fish and wildlife, while maintaining flood protection, sediment management and groundwater recharge.

The 4-5 year project will remove cement drop structures that are barriers to fish migration from the channel, replacing them with a roughened channel that provides passage for migratory fish. It also intends to stabilize stream banks and manage sediment, reduce water velocities with non-structural techniques, plant and develop a tree canopy to reduce water temperatures, and enhance and maintain native vegetation in the channel. Much of the vegetation enhancements will be accomplished with volunteers, including local residents, students, and community groups.
