Join the Wildlife Scavenger Hunt in Sunol March 22-23

The Alameda Creek Alliance is organizing a BioBlitz in the Sunol region of Alameda County on the weekend of March 22-23, 2014. What is a BioBlitz? The BioBlitz is a brief biological survey attempting to record all the living species within a designated area – a wildlife scavenger hunt. Volunteers will survey with scientists and naturalists to conduct an intensive field study in Sunol Regional Wilderness and the Sunol general area.

No special expertise is required, and it's a great way to explore and learn more about our local ecology and meet other with similar interests. You can choose to go out on your own during the 2-day event to record observations, or we'll set you up to be part of an expert-guided team. We're also recruiting field biologists, naturalists and taxonomic experts to participate in the BioBlitz. More information about the BioBlitz here.

Everyone who participates is invited to our wrap-up barbecue from 2-5pm on Sunday, March 23 - the final afternoon of the BioBlitz. We'll meet at a picnic area near the visitor center in Sunol Regional Wilderness to enjoy refreshments and discuss our observations and experiences.

Help Collect Signatures to Save Doolan Canyon in Dublin from Urban Sprawl

Signature collecting is now going on to qualify an open space initiative for the Dublin ballot. The Dublin Open Space Initiative of 2014 would set an urban limit line on the east side of Dublin where no city urban growth boundary now exists, protecting important wildlife habitat.

Developer Pacific Union has approached Dublin to annex Doolan Canyon and approve a 2,000-unit senior housing development on 1,450 acres in the canyon. Such a project would destroy the natural values of the area which is designated critical habitat for the California Red-legged Frog and the California Tiger Salamander. The Dublin city council responded by authorizing a general plan amendment study, the first step to annexing the property. Now is the time to protect Doolan Canyon before it's too late.

Signature collecting will take place on weekends at various locations throughout Dublin until the end of April. No previous experience is necessary. It's easy, people sign the petitions readily as they are fed up with the growth going on in Dublin now, and they thank us for doing this.
