Urgent – Support Protection of Huge N3 Ranch near Livermore



The 50,500 acre N3 Ranch, located south of Livermore, is being offered for sale for \$72 million. This huge cattle ranch covers 12% of the entire Alameda Creek watershed and contains significant wildlife habitat. Much of the property is located in watersheds that supply water to Alameda County Water District customers, and is above critical water supply facilities, including Lake Del Valle, Calaveras Reservoir, and Alameda Creek. This is the largest land sale in California. It is a critical opportunity to protect this land from development.

The Alameda County Water District (ACWD) is considering purchasing the N3 Ranch in its entirety, to protect a sizable portion of its watershed for generations to come.

The ACWD District Board of Directors will hold a special meeting this Thursday, October 17, to discuss the N3 Ranch sale. The meeting will be at 4:00 pm in the ACWD Multi-Purpose Room at 43885 South Grimmer Boulevard, Fremont. The meeting will discuss the potential merits of ACWD acquiring an ownership share in the N3 Ranch Property, and ACWD's interest in water supply, water quality, and watershed protection. Other topics include the potential establishment of a mitigation land bank, existing and potential future water resources-related facilities, partnering with other parties, costs, financial implications, water rates, and other related issues. ACWD purchasing this ranch would have many public benefits, in addition to protecting the water supply and the watershed from development. 80% of the ranch is located in the Alameda Creek watershed. ACWD could open up the property to hiking, camping, and recreation for the general public. This could be done through a partnership with East Bay Regional Parks District under a similar model to how ACWD now operates Quarry Lakes Park. Partnerships could be made with other agencies on a case by case basis after ACWD purchases the property.

Finances: The property could be financed with 30-year bond, which could then be issued as a green bond. In the long run this property would become an appreciating asset for ACWD. Financing could include 1% additions to forecasted ACWD rate increases over five years, or use some of the district's

\$10M rate stabilization fund, or a combination of both. The N3 Ranch is currently being offered at about \$1,425 per acre. If the land was sold with the possibility of future development, it would most likely sell for \$5,000 - \$10,000 per acre.
