Alameda Creek Alliance Picnic at Chouinard Winery - September 28



Join the Alameda Creek Alliance at [Chouinard Winery](#) in Palomares Canyon on Saturday, September 28. We will host a picnic for our members and supporters at the winery, from noon to 4 pm. Chat with the organization's staff and board members about current and upcoming Alameda Creek restoration projects.

We will provide picnic snacks and light food (antipasto, meat and cheese tray, vegetables, potato salad, coleslaw, garden salad, and dessert). Suggested \$5-10 donation for food. You can purchase your own wine by the glass or the bottle at the event.

Parking at the winery is very limited, so we will provide a shuttle van service to and from Sunol and Niles, before and after the event.

We will run a shuttle van to the winery from Niles at 11:40 am; from Sunol at 12:10 pm; and from Niles at 12:40 pm. The Sunol shuttle pick up will be at the [Sunol post office](#), 11925 Main Street. The Niles shuttle pick up will be at [Vallejo Mill Historical Park](#) (at the NE corner of Niles Canyon Road and Mission Boulevard). Return shuttles from the winery after the event will be at 2:30 to Niles; 3:10 to Sunol; and 3:45 to Niles.
